CITY ORGANIZED EVENT ON CITY PROPERTY

City Administration plans, or organizes the planning of the event, to ensure that there is a documented Event Plan (through self-permitting or otherwise) that includes, as appropriate for the event:

- 1. A suitable traffic plan
- 2. A suitable safety plan
- 3. A suitable sanitation and clean-up plan
- 4. All necessary licenses from other governments (Health Dept/Liquor Control Board)
- 5. Appropriate requirements on sub-participants like vendors and amusement device providers, including any participation fees, other governmental licenses and insurance.

The City must also manage the event to insure to the greatest extent possible that the Event Plan is carried out. This does not mean that volunteers cannot play a substantial role in all aspects of the event, only that the City Administration must exercise ultimate authority.

NON-CITY ORGANIZED EVENT ON CITY PROPERTY

An individual, alone or in conjunction with a group of individuals, or a legal entity (corporation-for profit/non-profit, LLC, etc.) plans, or organizes the planning of the event, to ensure that there is a documented Event Plan (including application for a City Special Event Permit if the requirements of the City ordinance are triggered) that includes, as appropriate for the event:

- 1. A suitable traffic plan
- 2. A suitable safety plan
- 3. A suitable sanitation and clean-up plan
- 4. All necessary licenses from other governments (Health Dept/Liquor Control Board)
- 5. Appropriate requirements on sub-participants like vendors and amusement device providers, including any participation fees, other governmental licenses and insurance.
- 6. Insurance for the event either through a standing Commercial General Liability policy already in place for a legal entity, or through a TULIP (Tenant Users Liability Insurance Policy) secured by an individual or group of individuals for the event.

The Duck Parade began when community members Terry Reim and Dixie Harris thought the community needed an event to celebrate the end of the rainy season as well as the wonderful improvements to Bridgeport Way. The yellow duck was adopted as the symbol of the parade and is now a community mascot! The parade begins at 10 a.m. at the corner of 27th Street and Bridgeport and continues south to 37th Street where it ends at the UPTown Cruisin' 2013 Car Show. Rain or shine, this annual parade is fun for the whole family. Bands, parade vehicles and marchers, walkers and bikers take part in this community outing!

Treasures in the Park

After the Annual Duck Parade, move on down to Homestead Park, where you can join the crowd in the hunt for "treasures" at this year's annual "Treasures in the Park" event, University Place's garage/antique and plant sale. Clean out those closets; bring out the antiques, reusable items and new treasures to sell. A RESOLUTION OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, DESIGNATING CERTAIN CITY SUPPORTED COMMUNITY EVENTS FOR 2013 AND DESCRIBING THE EXTENT OF CITY SUPPORT TO BE AFFORDED TO THOSE EVENTS

WHEREAS, the City Council recognizes that community events which take place on City property and/or in City rights of way are valuable in promoting the City's identity as a distinct community within the South Puget Sound area, support a high quality of life for residents, and promote economic development and tourism; and

WHEREAS, the City Council acknowledges that the benefits to the City from certain community events which take place on City property and/or in City rights of way result in ample consideration to the City to justify affording in-kind City support to those certain community events; and

WHEREAS, the City Council desires to list the community events that will receive in-kind City support in 2013, and the extent of the City support that would be available to those events;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PLACE, WASHINGTON:

- 1. <u>City Supported Events</u>: The following events are hereby designated as City Supported Events in 2013:
 - 1. Flower and Plant Show
 - 2. Duck Daze
 - a. Duck Parade
 - b. Treasures in the Park
 - c. Car Show
 - d. Art Fair in Market Square
 - 3. Concerts in the Park
 - 4. National Night Out
 - 5. UP Fest

 - 7. Cider squeeze
 - 8. UP for Art Atrium Arts and Concert Series
- 2. Extent of City In-kind Support: To the extent of available resources within the budgeted amount in the General Fund Community Events in the City's 2013-2014 budget the following will comprise the categories of City in-kind support available to designated community events. Within the following available categories, the City in-kind support to designated community events will be determined on an event-by-event basis by the City Manager or designee in consultation with the event organizers:
 - 1. Health portable toilets, hand wash stations, garbage disposal.
 - 2. Traffic Control (when required) Public Works and/or Police.
 - 3. Police Security for event when required.
 - 4. Fee waiver Waiver of facility, park rental, and permit fees.
 - 5. Insurance Coverage of City premises on which the events occur. The City's insurance does not cover claims against any vendors participating in the community event, including but not limited to product, food, beverage vendors or amusement device operators. Such vendors or amusement device operators must provide proof of insurance as a part of the event permitting process for each City supported event.
 - 6. Advertising City web, reader board.

- 3. <u>Legislative Finding</u>. The City Council finds that community events which take place on City property and/or in City rights of way in University Place are valuable in promoting and the City's identity as a distinct community within the South Puget Sound area, supporting a high quality of life for residents, and promoting economic development and tourism, and the City Council finds that the benefits to the City from the listed community events, results in appropriate consideration to the City to justify affording inkind City support to those community events. Specifically, by advertising, publicizing, or otherwise distributing information for the purpose of attracting visitors and encouraging tourist expansion and assisting the City's economic development activities.
- 5. <u>Effective Date</u>. This Resolution shall be effective immediately upon passage by the City Council.

A RESOLUTION OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, REVISING THE 2013 EVENTS RESOLUTION

WHEREAS, the City Council recognizes that community events which take place on City property and/or in City rights of way are valuable in promoting the City's identity as a distinct community within the South Puget Sound area, support a high quality of life for residents, and promote economic development and tourism; and

WHEREAS, the City Council desires to list the remaining 2013 community events that will be designated as City events for purposes of organization, permitting, insurance, and provision of specified in-kind City support for the remainder of 2013, and the extent of the in-kind City support that will be available to those events; and

WHEREAS, this resolution addresses only the remainder of 2013, and the City Council retains full discretion with respect to the City's role in community events in 2014;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PLACE, WASHINGTON:

- 1. <u>City Events</u>: The following events are hereby designated as City Events for purposes of organization, permitting, insurance, and provision of specified in-kind City support for the remainder of 2013:
 - 1. Concerts in the Park
 - 2. Pups in the Park
 - 3. Cider squeeze
 - 4. UP for Art Atrium Arts and Concert Series
- 2. Extent of City In-kind Support: To the extent of available resources within the budgeted amount in the General Fund Community Events in the City's 2013-2014 budget, the following will comprise the categories of City in-kind support available to the above-designated events. Within the following available categories, the City in-kind support to above-designated community events will be determined on an event-by-event basis by the City Manager or designee:
 - 1. Health portable toilets, hand wash stations, garbage disposal.
 - 2. Traffic Control (when required) Public Works and/or Police.
 - 3. Police Security for event when required.
 - 4. Insurance The City's insurance does not cover claims against any vendors participating in the community event, including but not limited to product, food, beverage vendors or amusement device operators. Such vendors or amusement device operators must provide proof of insurance as a part of the event permitting process for each City event.
 - 5. Advertising City web, reader board.
- 3. <u>Legislative Finding</u>. The City Council finds that community events which take place on City property and/or in City rights of way in University Place are valuable in promoting and the City's identity as a distinct community within the South Puget Sound area, supporting a high quality of life for residents, and promoting economic development and tourism, and the City Council finds that the benefits to the City from the listed events, results in appropriate consideration to the City to justify affording in-kind City support to those events. Specifically, by advertising, publicizing, or otherwise distributing information for the purpose of attracting visitors and encouraging tourist expansion and assisting the City's economic development activities.
