INSTRUCTIONS

GAMBLING TAX RETURN

1. The Gambling Tax Return form along with the payment is due on or before the 15th day of the month for taxes collected in the preceding month. If the 15th falls on a weekend or a government holiday, the next business day becomes the due date. Mail postmarked on or before the due date will not incur a penalty.

2. Make checks or money orders payable to: **City of University Place**
3. **Penalty:** Penalties due are calculated as follows:
 - 10% for 1 – 10 days past due
 - 15% for 11 – 20 days past due
 - 20% for 21 – 30 days past due
 - 25% for 31 – 61 or more days past due
4. **Interest:** Interest should be calculated and remitted on amount of tax from the first day following the payment due date, at the rate of one percent (1%) per month. $\text{Interest} = \text{Days Past Due} \times \text{Interest Rate (1\%)} \times \text{Total Tax}$.
5. Records supporting the amounts listed on the front shall be kept and maintained for a period of five years. The Director of Finance or his designee shall have the right to inspect and examine such records at reasonable times.
