Assessment of U.P. Streets' Pavement Underway

Residents of U.P. may spot a 2019 white Ford Transit van with two roof-mounted laser scanners cruising up and down the streets of U.P. The vehicle is assessing the condition of pavement across the city as part of a pavement management program that began on Feb. 28. The project is funded by Washington State Transportation Benefit District funds.



Downward-facing cameras mounted on the rear-end of the vehicle will image 88 center-line miles of roadway (which equates to 209 lane miles) in University Place, including arterials and neighborhood streets. The findings of the pavement assessment will be used to build a five-year plan for rehab of the surfaces.

If you encounter the van while driving, please be patient. It will travel at posted speeds while surveying roadway surfaces. If you have questions or would like additional information about this program, please contact **Jack Ecklund**, Director of Engineering, at 253.460.5411.

University Place earns WellCity Award

The Association of Washington Cities (AWC) recently released a list of the cities, towns, and other local governments that have earned the distinguished WellCity designation. The City of University Place is proud to be among this year's recipients. This recognition is bestowed to entities that meet the AWC Employee Benefit



Trust's stringent WellCity standards and demonstrate a commitment to employee health.

WellCity recipients are all part of the AWC Employee Benefit Trust (Trust), Washington State's largest local government employee health benefit pool for cities, towns, and other local governments. The Trust provides health benefits to more than 262 public entities and more than 36,000 employees and family members across the state. Employers that meet the WellCity standards earn a 2% discount on their medical premiums.

"The WellCity program benefits all Trust members. WellCity members as a group have a 50% lower medical and pharmacy trend than others, which helps to moderate the rate of premium increase for everyone," said Alicia Seegers Martinelli, AWC Interim Chief Executive Officer.

Tacoma Moratorium on Utility Disconnection ends March 31

Advanced notice on disconnection provides customers time to pay down \$30 million in past due balances



On Feb. 8 Mayor Victoria Woodards announced that the City of Tacoma will maintain the moratorium on utility disconnections until March 31, 2022. The March 31 date provides Tacoma Public Utilities' customers with advance notice so that TPU can provide assistance and access to resources that may help them make a plan for how to pay down past due balances and apply for available payment assistance before disconnections for nonpayment resume. At that time, Tacoma Public Utilities will begin the process for disconnecting service, ending the moratorium that was put in place at the start of the State of Emergency due to the COVID-19 pandemic. A similar moratorium set by the State of Washington ended in September 2021.

"This additional time is intended to give residents enough notice to make a plan to take care of outstanding balances, including access to programs and resources that may help," said Woodards. "We want to get these customers onto a payment plan right away and connect them with resources to catch them up on their payments so that no one loses service, especially the more financially vulnerable in our community."

When the moratorium ends on March 31, TPU will place all past due balances on an automatic, interest- free, 24-month installment plan. Making payments on past due balances now ahead of the March 31 date will lower the monthly amount customers will owe on their installment plans.

As a requirement of the National Pollution Discharge & Elimination System (NPDES), the City of University Place is required to provide a local municipal program that addresses the requirements of our NPDES Permit. Every year we provide opportunity for the public in our



community to review the program and make comments, pose questions, or provide recommendations.

The DRAFT 2022 Stormwater Management Program (SWMP) Plan continues to be available for review on the **City website**, and will remain available until the Public Hearing which is scheduled to take place at the U.P. City Council Meeting of

Monday, March 7.

There will also be opportunity to make public comment at the Public Hearing portion of the City Council Meeting of March 7.
