PROJECT OVERVIEW:

The City of University Place is developing a specific area plan for the Northeast Business District (see map next page). The district plan will establish a cohesive vision for the future of the Northeast Business District, along with goals, policies, and identified actions and projects needed to implement the district plan. The district plan will be integrated into the City's next Comprehensive Plan update, scheduled for 2024.

In addition to the vision, goals, policies, and actions, the District plan will include background and history of the District, an inventory of capital facilities and services to support growth, a market analysis, population and employment forecasts. The district plan also will address the items in PSRC's VISION Consistency Tool for Regional Growth Center Plans. The advisory group members will serve as liaisons to the broader community—bringing perspectives to the table beyond their own personal views that may be representative of their role/engagement as a member of the community.

While the advisory group is not a regulatory board and will not be in the role of approving or adopting the Northeast Business District Plan, the advisory group will make recommendations to Planning Commission and City Council based on their involvement in the planning process. The advisory group will be instrumental in developing the vision, policies, and actions proposed in the plan.
