





  - Korean survey responses = 3
  - Spanish survey responses = 2
- Paper survey responses = 15

#### Limitations


- Under-represented populations:
  - Asian-American
  - Black/African-American
  - Hispanic/Latino American
  - Households with incomes under \$75K
  - Youth (under 18)
- Over-represented populations:
  - White/European American
  - Households with incomes over \$75K
  - People over 65 years
  - People between 18-64

- Minimal responses for Spanish and Korean surveys
  - Potentially due to the Spanish and Korean speakers also speaking English and filling out that survey instead.


# How strongly do you agree with the City's current vision statement? (All respondents)



#### Vision Statement: Themes

(188 comments)

- Concerned who is included in UP and in the Vision Statement (28 comments)
  - Many wanted more emphasis on Diversity, Equity and Inclusion; a few preferred less
  - Race, Ethnicity, Gender, Orientation, Disability
  - Youth and families, seniors
  - Small businesses, economic diversity, living wage jobs, and housing types
  - "Citizen" does not include all



### Vision Statement: Themes


(188 comments)

- Greater focus on safety and emergency services (33 comments)
- Policing and responding to property crimes (20 comments)
- Support for families, youth, and youth programs (25 comments)
- Parks, recreation, and open space (15 comments)
- Support for small businesses/economic development (12 comments)



### Vision Statement: Themes from In-Person Public Outreach

- Desire for safe parks, recreation programs including community/rec center/pool
- Maintaining a small town feel while growing as a community
- How to balance caring for people with caring for the environment
- Value of open space and green environment
- Concerns about climate change
- Support for diversity and inclusivity
- Curiosity about new ADU rules, with many interested in adding an ADU to their home
- Negative comments about large multifamily buildings

"Add something about taking care of the environment, making sure our land, water and air are clean."




"[Include] support for small business, arts and cultural opportunities."

"We should use specific terms for inclusivity such as: we are inclusive for all people, and celebrate our unique diversities which combined, make our community."




# What types of housing choices (in addition to single family and duplexes) should UP consider when planning for required new housing units? (all respondents)












## Housing Types: Main Themes from Comments



# EV Charging Stations: Main Themes from Comments (56 comments)

- Not supportive of public sector involvement with EV charging stations (11 comments)
- Located near community centers or recreational amenities (9 comments)
- Sited on existing gas stations (9 comments)

## Consultant Team Analysis

Ideologically very diverse responses -> Need for compromise policies

Density housing near transit and amenities

Balance new housing growth with a focus on parks, recreation, open space

Dominant community concerns might fall outside the Comprehensive Plan (e.g. public safety)

### Consultant Team Recommendations

#### Engagement

Continue and deepen community engagement practices within the Planning Department as community members expressed appreciation.

#### Relationships

Planning Department can build relationships with community organizations, especially those that serve diverse populations (income, race, ethnicity, language) to enable more successful grassroot engagement strategies.

#### Civic Education

Continue to provide civic education about housing policy/laws at the state vs. local level, as well as UP's jurisdictional control (e.g. its geographic boundaries).

#### Languages

Consult with community organizations (not just public data) regarding priority languages for translation.



The State of Washington is requiring University Place to plan for 5,620 new housing units by 2044.


What do you think this new housing should be near? (You can choose up to THREE, if any)



#### How old are you?


